

TERMS & CONDITIONS



1. FROM 6 NOV

Spend \$60 (\$50 for U-POPP Members) to redeem:

2. FROM 20 NOV

Spend \$180 (\$150 for U-POPP Members) to redeem a Cheese Cutlery Set

How to qualify:

- Maximum 3 same-day combined receipts** are allowed for redemption in person on the same day of purchase.
- Shoppers are required to be present and provide a valid mobile number for redemption.
- Receipts obtained after 9:30pm can be redeemed on the following day only
- Only one enrichment centre's receipt will be accepted as a fixed amount of \$50 for redemption per shopper per day.
- Limited to (one) 1 redemption per shopper per day**, regardless of total amount spent, while stocks last.
- United Square's Concierge is open daily from 10:00am to 9:30pm. Redemption can be done over Concierge, L1. Last redemption is at 9:15pm.

3. GENERAL TERMS & CONDITIONS

Requirements

- d. Submission of receipts must be done by 11.59pm on the next day after the issuance via U-POPP Mobile App to qualify for the promotion.

Receipts

Only original receipts with full payment are accepted based on the net total amount reflected on the receipt. NETS/ credit card slips/ duplicate/ handwritten/ third party receipts (i.e. receipts that are not from any Participating Merchant) will not be accepted. Receipts from any mobile payment platforms/applications (e.g. FavePay, GrabPay) will not be accepted. Receipts cannot be reused for other promotions.

Transaction receipts that we do NOT accept.

- a. Purchase of UOL gift cards
- b. Purchase of Tenant's Shopping Voucher
- c. AXS Station, ATMs, Cash card top-ups
- d. Banks
- e. Non-tenant atrium vendors
- f. Medical receipts (Dental/ clinic/ TCM)

Receipts for purchase of gift vouchers and payment of phone bills/ phone cards/ parking coupons are not valid.

POPPoints
